2024 Collection Agreement between NID and USFS

WHEREAS, On May 11, 2022, staff brought a discussion to the Board regarding not renewing the Special Use Permit with the USFS to operate and maintain USFS campgrounds and land within the Jackson Meadow Complex and Bowman Corridor. Instead, NID would enter into a collection agreement that would allow the District to pay the USFS to operate their campgrounds.

WHEREAS, The Board has supported and approved collection agreements in both 2022 and 2023 between the USFS and the District.

WHEREAS, NID staff has worked with the USFS on their 2024 Collection Agreement Financial Plan. The USFS 2024 Collection Agreement Financial Plan is requesting \$399,107, the funds would help operate and maintain their campgrounds and lands in the Jackson Meadows and Bowman Corridor areas.

WHEREAS, The Recreation 2024 Operating Budget, budgeted \$399,107 in account 30250-52515 for the USFS 2024 Collection Agreement Financial Plan.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Nevada Irrigation District to approve the following:

1. The General Manager to execute the 2024 Collection Agreement Financial Plan between Nevada Irrigation District and the United States Department of Agriculture, U.S. Forest Service, Tahoe National Forest.
 - \$399,107 for the 2024 Collection Agreement Financial Plan.
