MAINTENANCE

RECOMMENDATION: Consider awarding the Cascade Shores Phase V Final Asphalt Paving Project, Contract No. M2016-02, Project No. 1003, to Central Valley Engineering & Asphalt, Inc. of Roseville, California, in the amount of \$184,000.00, and authorizing the General Manager to execute the necessary documents.

BACKGROUND: As part of the five year project to replace the undersized and deteriorating water distribution system throughout the Cascade Shores community, NID crews recently completed the (a) installation of approximately 8,000 lf of 8-inch water main line and (b) replacement of 65 services and 8 new dry barrel fire hydrants (Phase V).

This resulting trench paving effort will include the installation of a final asphalt patch over both water main and 41 service line trenches, in accordance with the conditions set forth in the Encroachment Permit issued by the County of Nevada for this project.

District Staff solicited bids from five local paving contractors, three of which responded (see attached Bid Results). Bids were publicly opened on August 31, 2016 and Central Valley Engineering & Asphalt was the low bidder.

BUDGETARY IMPACT: The cost for the final asphalt paving for this project has been accounted for in the Pipeline Replacement Program, 2016 Engineering Budget.


