

RESOLUTION NO. 2020-20

OF THE BOARD OF DIRECTORS OF THE NEVADA IRRIGATION DISTRICT

AUTHORIZING CHANGES IN WAGES, HOURS, AND TERMS AND CONDITIONS OF EMPLOYMENT FOR EMPLOYEES REPRESENTED BY AFSCME -OFFICE, FIELD AND SUPERVISORY UNITS

WHEREAS, Nevada Irrigation District (hereafter "NID") and the recognized bargaining representatives representing employees within American Federation of State, County and Municipal Employees, Local 146 (hereinafter "AFSCME") have been engaged in meet and confer sessions regarding wages, hours, and terms and conditions of employment that are set out in the Comprehensive Memorandum of Understanding, July 1, 2017 to June 30, 2020, Governing Wages, Terms, and Conditions of Employment (hereafter "2014 MOU"); and,

WHEREAS, the 2017 MOU had a term expiring on June 30, 2020, and in accordance with its terms has been continued in force and effect pending negotiations; and.

WHEREAS, following several negotiating sessions, NID and representatives of the AFSCME agreed to temporarily suspend negotiations due to the COVID-19 pandemic; and,

WHEREAS, NID and AFSCME met and conferred virtually to consider an extension of each Unit's current MOU and agreed to terms and conditions by a Side Letter for the current MOU regarding wages, hours and terms and conditions of employment for Office, Field and Supervisory Units, for the period after expiration of the 2017 MOU for one year, expiring June 30, 2021 (hereafter, collectively, "2020-2021 MOU"); and

WHEREAS, the Board of Directors has authorized and approved such agreements and directed that a resolution be prepared incorporating such changes in a successor Memorandum of Understanding; and,

WHEREAS, the agreed upon wages, hours, and terms and conditions of employment for employees in the Office, Field and Supervisory Units for the successor MOU and Side Letters are set forth in Attachments A, B and C.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Nevada Irrigation District, that Attachment A and all attachments thereto, are hereby approved.
